#### **Promoter's Conditions**

- 1. This open meet will take place at The Exe Valley Leisure Centre, Tiverton, Devon. It will be run in accordance with A.S.A. Laws and Regulations, ASA Technical Rules of Racing, and the rules and conditions of this competition.
- 2. Entries may be held on a computer solely for the purposes of this competition and consent, as required by the Data Protection Act 1998; the holding of personal information on computer will be deemed to have been given by the swimmers & / or parents on submission of the entry. Personal Data will be available for inspection during the Meet on application to the Promoters.
- 3. Ages as at midnight on 8th November 2015. Age groups for awards are: 9, 10, 11, 12, 13, 14, 15 & over.
- 4. A Club official MUST sign the entries summary form.
- 5. The closing date is MIDNIGHT on SUNDAY 4<sup>th</sup> October 2015. Late entries may be accepted at the discretion of the promoter. The entry fee is £5.00 per 50m event, £6.00 per 100m and 200m events. As the meet is licensed, the appropriate levy will be paid to the ASA. All cheques to be made payable to 'Tiverton Swimming Club' and where possible Club entries should be consolidated; one cheque per Club. Entries must be made on the forms provided (photocopies will be accepted), one per competitor or by zipped Hy-tek file. Entries must enclose a SAE for return of a print out of accepted entries for checking. Entries without the correct fees, illegible entries or incomplete entries (ASA numbers, birthdays, and times) or SAE will not be processed. Entries to be returned to: Sally Tovey, 52 station Road, Hemyock, Devon. EX15 3SE.
- 6. Please ensure the correct postage is on the entries. In order to assist with the smooth running of the meet, entries may be restricted as per condition 8 below; any entry not accepted will be refunded in full. NO OTHER MONIES WILL BE REFUNDED. All swimmers must be members of a club affiliated to the A.S.A.
- 7. No refunds will be made after the closing date
- 8. Entries will be accepted on a 'first come, first served' basis with priority given to clubs providing details of officials. The Promoter reserves the right to reject entries if events are over-subscribed. All events will be swum with consolidated heats seeded on entry times. Entry times must comply with the 'no faster than' and 'no slower than' times in the table provided with the entry pack. Clubs will receive a printout of their entries for checking. All entries are accepted on the understanding that the competitors and Club accepts the Promoter's Conditions. No refunds will be made to competitors who withdraw after advice of acceptance. Where possible entries of 5 or more competitors per Club should be sent by Hytek zip file or disk to Sally Tovey (address above). Where the number of entries is lower than expected the Promoter reserves the right to accept entries below the 'no slower than' time. If the number of entries within the qualifying times for an event is high, the Promoter reserves the right to limit entries to enable the meet to comply with the requirements of the licence; any deletions will ensure an equal balance of swimmers across the age groups based on entry time.
- 9. All swimmers must be registered with the ASA as a category 2 swimmer and have their ASA membership cards available should they be required.
- 10. All events are HDW. Awards will be made to 1<sup>st</sup>, 2nd and 3<sup>rd</sup> in each of the specified age groups for each event.
- 11. Coaches' passes will be issued at a cost of £10 each and this will entitle them to admission to all sessions and a programme. Entry to poolside will not be permitted without a pass. It is the responsibility of each club to ensure that an appropriate number of adults are poolside throughout the entire meet; these adults will be responsible for the conduct of their swimmers at all times.
- 12. Team managers/coaches must ensure swimmers report to the marshals in the pool changing village one event before their event. Races will not be delayed where a swimmer is missing.
- There will be no paper results issued at the meet; they will be available on <u>www.tiverton-swimming.co.uk</u> and, on request to Sally Tovey, by email compsec@tiverton-swimming.co.uk.
- 14. All participants must observe the safety precautions and other displayed requirements in operation at the Exe Valley Leisure Centre. Neither the Meet Management, the Promoters nor Tiverton Swimming Club will be responsible for any loss or damage occurring during this Meet. Lockers are available for £1 in the pool Changing Village. Swimmers may not use the changing areas adjacent to the gym or dance studios.
- 15. No spectator, swimmer, team manager or coach is permitted to park at the Exe Valley Leisure Centre. There is ample parking at Tiverton High School opposite the EVLC. The team of Registered Officials will receive EVLC parking permits.
- 16. Swimmers with disabilities are welcome to enter this meet, and the no faster than/no slower than times will not apply. Please advise us of any special requirements and we will do our best to meet them in consultation with their coaches.
- 17. Deletion sheets will need to be completed and handed in prior to the commencement of warm up for each session. Team managers are responsible for ensuring this is completed for their Club.
- 18. In line with Child Protection legislation no spectator will be allowed on poolside and any person wishing to take any kind of photograph is required to provide name, address and signature and wear the badge provided.
- 19. Swimmers will not be permitted to sit in the spectators' balcony and spectators should not reserve seats for them.
- 20. The use of air horns, vuvuzela's or any other mechanical horns is strictly forbidden and will be asked to cease using during the event. Should this be ignored the item will be confiscated until the end of the event when it will be returned.
- 21. Events will be 'single-start', and will have 'over the top' starts, except in backstroke events.
- 22. Spectator admission is £3.00 per spectator. In line with the Health and Safety regulations of the EVLC spectator numbers may need to be restricted. If this is the case admission to the balcony may be limited to one or two members of each family at any one time. There is extra seating available in the foyer. The organisers respectfully ask that if these limitations need to be enforced they are respected. Programmes £3.00. There will be a raffle.
- 23. The swimming pool is a 6-lane, 25m pool, with a separate swim-down pool adjacent. Anti-turbulence lane ropes will be used; electronic timing and times display. Note: the electronic timing is provisional and may be over ruled by the referee.
- 24. The Meet Management and Promoters reserve the right to change the Meet rules at their discretion. Any matters concerning the Meet not covered in these rules will be dealt with according to the laws of the Sport and at the discretion of the Meet Management or the Promoters.
