14th Tiverton Sparkler 2021 **Promoter's Conditions**



General

- 1. The competition will be held under Swim England Laws and Regulations and Swim England Technical Rules of Racing. This event is licensed by Swim England at Level 3 for entry into Regional and County Championships and other Meets at Level 1 or 2.
- 2. All swimmers must be members of a club affiliated to Swim England and must be registered as a Category Two swimmer. Entries from swimmers not registered as Category Two will be rejected.
- 3. The event will be held at the Exe Valley Leisure Centre, Tiverton, Devon. The pool is 25m long and has six lanes with a separate swim-down pool adjacent. Lanes will be equipped with anti-turbulence ropes and electronic timing with a digital display will be used. There will be a secondary strobe available at the meet.

 Note: the electronic timing is provisional and may be over-ruled by the Referee.
- 4. The Lead Referee may change the Meet Conditions as necessary during the running of the Meet to ensure the continued smooth running of the event in case of emergency or situations beyond the control of the Meet Management. Any matters concerning the Meet not covered in these rules will be dealt with according to the laws of the Sport and at the discretion of the Lead Referee.
- 5. The Meet Promoter will make every effort to run the event. In any situation that the meet must be cancelled competitors are not eligible for full refunds of their entry fees. Proportionate refunds may be made but only after the promoter has covered all incurred costs. In any situation that the meet must be run at either unlicensed or at a lower licence level, competitors are not eligible for refunds of their entry fees.

Events

- 6. All events are HDW.
- 7. Heats will be swum mixed with all age groups combined and swimmers will be seeded by entry time.
- 8. Events will be pre-seeded and no amendments will be made to heats on the day.
- 9. 'Over the top starts' will be used wherever possible.
- 10. Team managers/coaches must ensure swimmers report to the marshals near the pool changing village 4 to 5 heats before their race. Races will not be delayed where a swimmer is missing.
- 11. Ages as at midnight on 28th November 2021.
- 12. Awards will be made separately for boys and girls placed 1st, 2nd and 3rd in each age group in each event.

Entries

- 13. This gala will be filled on a first come first served basis. The closing date will be on or before 4th November 2021.
- 14. The promoter reserves the right to accept or reject entries and also restrict entries in order to complete the meet within the time available. Any entries not accepted will be refunded in full.
- 15. Late entries may be accepted at the discretion of the Promoter but 'deck' or substituted entries will not be accepted on the day of the Meet.
- 16. Entry times must comply with the 'no faster than' times in the table provided with the meet pack. Clubs with swimmers who do not have recorded times are encouraged to submit a realistic estimate so that session times can be planned reliably. Entries made with no entry time will be rejected.
- 17. Swimmers with disabilities are welcome to enter this Meet, and the 'no faster than' times will not apply. Please advise the Meet Management of any special requirements and we will do our best to meet them in consultation with their coaches.
- 18. Entries of 3 or more swimmers from the same club must be made electronically to be submitted in one single file per club. The meet Hy-Tek file will be available from the TSC website. Entries along with a **completed Entries**Summary Form to be emailed to sparkler@tiverton-swimming.co.uk. Clubs without access to Hy-Tek Team Manager software are advised to download the free 'Lite' version from: https://hytek.active.com/downloads.html





- 19. Clubs will receive an email detailing their entries for checking. It is the responsibility of the submitting club to ensure the accuracy of entries in the file. Mistakes made by clubs in their entries will not be corrected by Meet Management. Note that incomplete or incorrect swimmer's details in the file will prevent their times being uploaded to the British Rankings.
- 20. The entry fee is £6.50 per event.
- 21. Payment of fees should be made by BACS to AC 91463802 / SC 40-44-18. Please reference your Club code and 'Sparkler'. Alternatively, payment may be made by cheque made payable to 'Tiverton Swimming Club'. Entries will not be accepted without payment of the correct fees.
- 22. No refunds will be made to competitors who withdraw after advice of acceptance other than on medical grounds. A doctor's note or equivalent must be provided.
- 23. All entries are accepted on the understanding that the competitors and Club accepts the Promoter's Conditions.

Coaches, Team Managers & Officials

- 24. Clubs attending the Meet must purchase at least one coach/team manager pass for every 10 swimmers entered. Passes must be ordered with club entries and all coaches and team managers must hold a current DBS accreditation and be registered with Swim England.
- 25. Passes will be issued at a cost of £10 each and this will entitle the holder to admission to all sessions and a programme. Entry to poolside will not be permitted without a pass. It is the responsibility of each club to ensure that an appropriate number of adults are poolside throughout the entire Meet. These adults will be responsible for the conduct of their swimmers at all times.
- 26. There will be no paper results issued to clubs at the Meet. Results will be emailed out to participating clubs and made available on the club website as soon as possible after the Meet. Additional requests may be made by email to sparkler@tiverton-swimming.co.uk.
- 27. Visiting clubs entering 7 or more swimmers in a session are requested to provide at least one qualified and licensed official in that session. No club will be penalised if they cannot meet this requirement.

Safeguarding, Health and Safety

- 28. All participants must observe the safety precautions and other displayed requirements in operation at the Exe Valley Leisure Centre. Neither the Meet Management, the Promoters nor Tiverton Swimming Club will be responsible for any loss or damage occurring during this Meet. Lockers are available for £1 in the pool Changing Village. Swimmers may not use the changing areas adjacent to the gym or dance studios.
- 29. Tiverton Swimming Club uses a computer to manage entries and results. As required by the Data Protection Act 2018, submission of entries implies consent to the holding of personal information on computer. Personal Data such as name, club, year of birth, recorded and entered times may be made public during or after the meet. All Personal Data will be retained in a confidential manner and access to such Data will be restricted by the Meet Manager and limited to only those operating the meet software in order to process results.
- 30. Anyone wishing to use a device capable of photography or video recording must take careful note of the information posters. The full SE Guidance on Photography can be found in Wavepower the Child Safeguarding Policy and Procedures available at www.swimming.org/swimengland/wavepower-child-safeguarding-for-clubs/.
- 31. Government and pool operator Covid-19 restrictions permitting, admission to the Spectator' balcony will cost £3.00 per adult with no charge for accompanied children. Spectators will not be allowed on poolside.
- 32. Swimmers will not be permitted to sit in the balcony and spectators should not reserve seats for them.
- 33. In line with the Health and Safety regulations of the EVLC, spectator numbers may need to be restricted. If this is the case then admission to the balcony may be limited to one or two members of each family at any one time. The organisers respectfully ask that if these limitations need to be enforced then they are respected.
- 34. Spectators, swimmers, team managers and coaches are not allowed park in the Exe Valley Leisure Centre car park but there is ample parking available at Tiverton High School opposite the leisure centre. Only Officials assisting at the meet will be permitted to use the EVLC car park.


