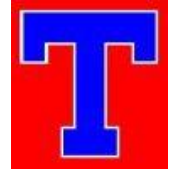

PROMOTER'S CONDITIONS

1. This meet will take place at The Exe Valley Leisure Centre, Tiverton, Devon, and will be run in accordance with A.S.A. Laws and Regulations and ASA Technical Rules of Racing.
2. Entries may be held on a computer solely for the purposes of this competition and consent, as required by the Data Protection Act 1998; the holding of personal information on computer will be deemed to have been given by the swimmers and/or parents on submission of the entry. Personal Data will be available for inspection during the Meet on application to the promoters.
3. **Ages as at midnight on Sunday 23rd July 2017.** Age groups for awards are: 8 & under 9, 10, 11, 12, 13, 14, 15 & over.
4. **SWIMMERS AGE 8 & UNDER ON THE DAY MAY ONLY ENTER 50m EVENTS PLUS 100m Individual Medley.**
5. The closing date is **MIDNIGHT on Sunday 1 6th July 2017.** Late entries may be accepted at the discretion of the promoter.
6. **The entry fees are as follows: £12.00 for 5 events or less, £20 for 6 or more events.** As the meet is licensed, the appropriate levy will be paid to the ASA. All cheques to be made payable to 'Tiverton Swimming Club'. Entries must be made on the forms provided (photocopies will be accepted), one per competitor. Entries without the correct fees, illegible entries, and swimmers not up-to-date with Tiverton Swimming club membership fees will not be processed. Entries to be returned to: SALLY TOVEY – compsec@tiverton-swimming.co.uk. **All swimmers must be registered with Tiverton Swimming Club.**
7. **No refunds will be made after the closing date**
8. The Promoter reserves the right to reject entries if events are over-subscribed, full refund will be given. All events will be swum with consolidated heats seeded on entry times. A printout of accepted entries will be on display at Exe valley Leisure centre for checking after the closing date. All entries are accepted on the understanding that the competitors accepts the Promoter's Conditions. No refunds will be made to competitors who withdraw after advice of acceptance. If the number of entries for an event is high, the Promoter reserves the right to limit entries to enable the meet to comply with the requirements of the licence; any deletions will ensure an equal balance of swimmers across the age groups based on entry time.
9. All swimmers must be registered with the ASA Category 1 or 2.
10. All events are HDW. Awards will be made to 1st, 2nd and 3rd in each of the specified age groups for each event.
11. Times recorded at this meet may be suitable for entry into Devon County Championships* and Licenced meets**.
*subject to County approval
**It will be down to individual meet promoter's conditions to accept entry times gained at a Level 4 meet.
12. Swimmers must report to the marshals in the pool changing area one event before their event. Races will not be delayed where a swimmer is missing.
13. Provisional results will be available at the meet, and; they will be available on www.tiverton-swimming.co.uk
14. All participants must observe the safety precautions and other displayed requirements in operation at the Exe Valley Leisure Centre. Neither the Meet Management/Promoters/Tiverton Swimming Club will be responsible for any loss or damage occurring during this Meet. Lockers are available for £1 in the pool Changing Village. Swimmers may not use the changing areas adjacent to the gym or dance studios.
15. Tiverton Swimming Club Registered Swimmers with disabilities are welcome to enter this meet. Please advise us of any special requirements and we will do our best to meet them.
16. **Safeguarding:** Persons wishing to use photographic equipment, including mobile phones with photographic capacity, should refer to ASA Wavepower Child Protection Guidelines, available at www.swimming.org. Spectators will not be allowed on poolside.
17. Swimmers will not be permitted to sit in the spectators' balcony and spectators should not reserve seats for them.
18. The use of air horns, vuvuzela's or any other mechanical horns is strictly forbidden and will be asked to cease using during the event. Should this be ignored the item will be confiscated until the end of the event when it will be returned.
19. Programs will be available at a cost of £1.00. There will be a raffle.
20. The swimming pool is a 6-lane, 25m pool. Anti-turbulence lane ropes will be used; electronic timing and times display. Note: the electronic timing is provisional and may be over ruled by the referee.
21. Any matters concerning the Meet not covered in these rules will be dealt with according to the laws of the Sport or the Referee.

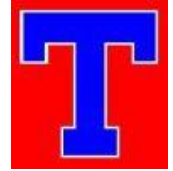
